POLL VOTING

Pursuant to Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad and the Company's Constitution, all the resolutions set out in the Notice of the 29th AGM will be voted upon by poll.

The Company has appointed Symphony Corporate Services Sdn Bhd as the Poll Administrator to conduct the polling process and Propoll Solutions Sdn Bhd as the Independent Scrutineer to verify the poll results.
